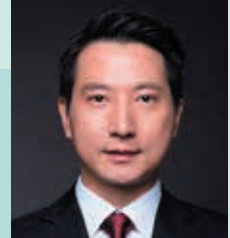
Message from Head Juror 首席評審致辭

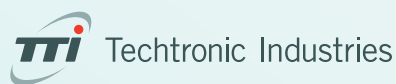

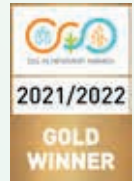

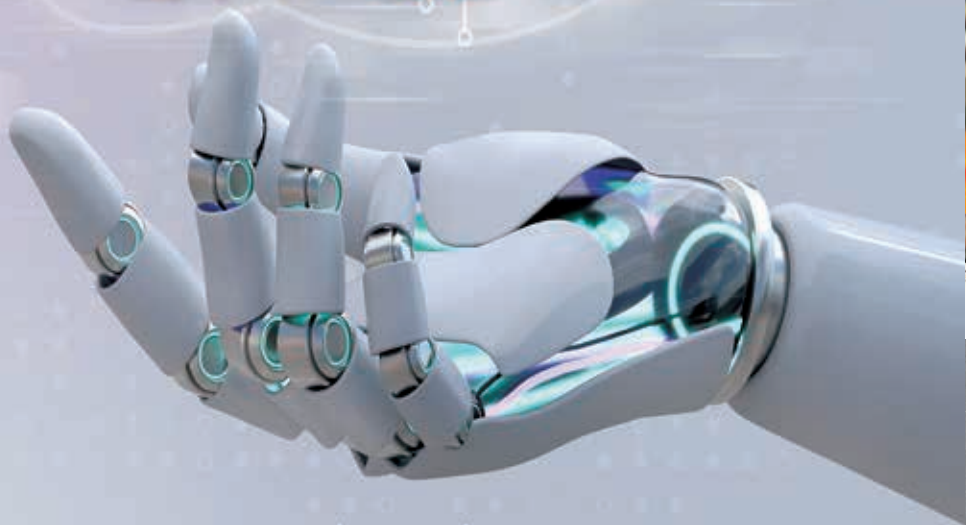
